# **Our Flexible Work Environment**

#### Primary purpose of position

APS5 Test Analyst is accountable under limited direction to perform moderately complex work to deliver and maintain test scripts and specifications and their execution against software products and systems to assure Agency products are fit for purpose and vendor healthcare software products conform to the Agency requirements and standards.

For product testing, the Test Analyst is responsible for:

- Producing test scripts and executing tests for Agency products, such as the CP Validator.
- Participating in consultation with internal project teams as necessary to construct and gain feedback and support for the team's deliverables.

For conformance testing, the Test Analyst is responsible for:

- Developing and maintaining Conformance Test Specifications and executing these in vendor involved observed sessions to assure the software's conformance to published requirements.
- Assisting vendors in the health software industry to understand and apply the conformance tests. This includes developers and testers employed by software vendors and health jurisdictions.

#### **Relevant duties**

#### 1. Leadership and Accountability

- Provide technical expertise that contributes to business outcomes by participating in and contributing to quality control and project management processes, tools and methods and document reviews, ensuring test document quality is maintained.
- Apply strong understanding of all aspects of the systems/software development cycle to assist and support Program Managers, Business Analysts, Solution Architects and other Test Analysts to plan tests, test processes and software tools, balancing competing priorities to ensure testing and conformance services are delivered in agreed timeframes; share knowledge with other test analysts in the Risk and Assurance Group.
- Participate in consultation with internal project teams as necessary to construct and gain feedback and support for the team's deliverables.

#### 2. Management Diversity and Span

- Assist, support and contribute to forward planning of testing work schedules, providing progress reporting to team line manager/s and project management.
- Assist in the creation of testing and conformance work instruction documentation and reviewing documents and artifacts that are created within the team as a quality control mechanism.

#### 3. Job Context and Environment

- Design, develop and execute the test cases & test scenarios for software products and tools, including Clinical Package Validator, IQ Rules, Secure Message Delivery, etc
- Write Test Summary/Completion Reports and the end of testing to provide results from testing and confirm products "fit for purpose" and vendor systems meeting conformance.
- Participate in the development of process improvements to test specifications, test data and conformance methodology to ensure continuous improvement or quality within the Conformance Test Specification.

#### 4. Independence and decision-making

- Work independently to construct new test data as per the conformance test specification product requirements utilising previous experience of designing, building and executing test scripts against product requirements, wireframes, technical specifications and Australian and international standards.
- Develop and maintain Conformance Test Specifications and execute these in vendor involved observed sessions to assure the software's conformance to published requirements.
- With direction from the manager, suggest course of action to stakeholders in relation to testing enquiries; identifying problems or issues (defects, etc) during testing and managing them through to their resolution, escalating more complex information and vendor material issues.

#### 5. Stakeholder Management

- Build and maintain internal and external stakeholder relationships to ensure testing and conformance services are delivered within agreed service levels.
- Support and guide vendor community developers and testers in their take-up of Conformance Test Specifications and supporting documentation, guiding, and observing the testing of vendor software for conformance to the eHealth specifications.

#### **Essential requirements**

Ability to obtain and maintain a Baseline security clearance with the ability to obtain and maintain a higher clearance if required by the Agency
