




# Accessing Advance Care Planning Information

*Note: These steps assume that your software is connected to the My Health Record system, the patient has a My Health Record and their individual healthcare identifier (IHI) has been validated in your system*

<p><b>STEP 1:</b></p> <p>To access to the patient’s My Health Record, select the <b>Open My Health Record</b> drop-down menu, then select <b>View My Health Record Overview</b></p>	
<p><b>STEP 2:</b></p> <p>Scroll down and click on the <b>Patient Document List</b> shortcut tile.</p>	
<p><b>STEP 3:</b></p> <p>The <b>Patient Document List</b> will display. You will need to adjust the <b>Document Types</b> filter to include <b>Advance Care Planning Documents</b>. You may also need to adjust the <b>date filter</b> range. Click <b>Refresh</b>.</p> <p>To find the information quickly, you can click on the sort arrow next to <b>Document</b>. The <b>Advance Care Information</b> will appear at the top of the list. Double-click <b>Advance Care Information</b> to open it.</p>	

<p><b>STEP 4:</b> An <b>Advance Care Plan/ Directive</b> will display information related to a person’s wishes for future medical treatment.
