


Viewing Clinical Documents in My Health Record

Note: These steps assume that your software is connected to the My Health Record system, the patient has a My Health Record and their individual healthcare identifier (IHI) has been validated in your system

STEP 1:


Open the patient's clinical file then select the **My Health Record** button.



STEP 2:

A separate browser window will launch with the patient's My Health Record in view. You will be shown the **Health Record Overview page** by default.

Use the **tabs** at the top of the page to find and view documents in the patient's My Health Record.

STEP 3:

Click on the **arrows** to the left of the field to expand your area of interest.

Then click on the blue **View Document** icon to open a particular document.
