

Accessing Immunisation Information

Note: These steps assume that you have an individual PRODA account, your HPI-I has been linked to your organisation's HPI-O and the patient has a My Health Record.

STEP 1:

Open the **National Provider Portal** and search for your patient by entering their:

- Last name
- Date of birth
- Sex
- A unique numeric identifier, either their Medicare or DVA number, or their Individual Healthcare Identifier (IHI).

Click on the **Immunisation Records** tab to open the Immunisations page.

Immunisations

Immunisation information displayed in 'Immunisation status' and 'Next immunisations due' comes from the Australian Immunisation Register. Individuals can get an immunisation history statement or COVID-19 digital certificate from their My Health Record.

Immunisation status

ⓘ This individual has not received all required COVID-19 vaccines.

The COVID-19 Immunisation Status field displays as:

- 'This individual has not received all required COVID-19 vaccines' if someone has had only one vaccine; or
- 'This individual has received all required COVID-19 vaccines'.

If no COVID-19 vaccines have been received, the status isn't displayed.

Immunisation information displayed in 'Immunisation status' and 'Next immunisations due' comes from the Australian Immunisation Register.  Individuals can get an immunisation history statement or COVID-19 digital certificate from their My Health Record.

The **Next immunisations due** status will indicate due and overdue COVID-19 vaccinations and National Immunisation Program (NIP) vaccinations.

If there is additional information recorded in the Australian Immunisation Register, this is displayed in a **Notices** section. This may include details about immunisation exemptions or participation in vaccine trials.

The **Immunisation history** table displays available immunisation information recorded in the Australian Immunisation Register and other documents in a patient's My Health Record such as a Shared Health Summary or Event Summary.

The **Source** filter can be adjusted to make immunisation records visible from a specific source only.
